



ADDENDUM

This Addendum forms an integral part of FIT Rate Agreement between Dukes the Palm Dubai Hotel & Preferred DMC Partner 2026 – 2027.

The Parties hereby agree to introduce the following updates to the Agreement. These amendments do not affect the contracted commercial rates and remain supplementary in nature.

1. Update in Half Board Dine Around Plus & Full Board Dine Around Plus

Terms and Conditions:

- During **breakfast**, guests may enjoy juices and water from the beverage dispensers at Great British Restaurant (GBR).
- **HB+**: Two beverages (soft or alcoholic) are included during **dinner only**
- **FB+**: Two beverages (soft or alcoholic) are included during **lunch**, and an additional two beverages during **dinner**.
